Application Deadline is August 31st.

Applications will be reviewed by the Fund Advisory Committee and submitted to the Nebraska Community Foundation for final approval.

Priority for grants may be given to projects that include partnerships and other sources of funds. These may include traditional financing, private donations, other granted funds, requests for matching funds or other sources of project financing.

All applications may be subject to requests for more information.

What we need from you to process this application:

- 1. Completed grant application form.**
- 2. A copy of your organization's IRS tax exemption letter or 501c3 form.**

In order to process any future grant applications from your organization, we will need public recognition of the grant within one year of the grant award.

- a. A grantee is expected to recognize the grant in public communications relating to a funded project or program. Ex: "This project was supported by funding from the Keith County Foundation Fund in partnership with *list of all project partners*."
- b. Provide two (2) pictures (electronically, 300 dpi or greater) of the grant funds being put to use by the recipient in the community.
- c. Provide a narrative about the impact of the grant and how it is used for the betterment of Keith County.
