KCFF to **Participate** in NCF **Hometown Intern Program: Most** selected for **2024**

Keith County Foundation Fund will once again participate in the Nebraska Community Foundation Hometown Intern Program. This will be KCFF's third year of participation in the now four-year-old program; a program that has grown and evolved into an impressive curriculum used to offer local college students an opportunity to design and work on projects which recognize and focus on local assets. Through these projects, through peer learning, and with the help of NCF and KCFF members, interns are able to view their hometowns through a different lens, often with new recognition and appreciation.

Each intern will work from their hometown for the summer. HTI projects will vary depending on community needs and the talents and interests of each intern. Although statewide participants will meet and work together on a variety of assignments and several peer learning sessions, each intern will have an experience unique to that intern. The purpose of the program is to create lasting connections and provide valuable experience that will impact the interns throughout their lives. The work of the interns will promote community development locally and statewide in meaningful ways and identify and utilize community assets already in place. Significantly important is the way the program fosters a positive emotional connection with these special hometowns.

The 2024 KCFF Hometown Intern, Caleb Most, was selected earlier this year. Most is currently a first-year student at the University of Nebraska-Lincoln where he studies agricultural education. He brings with him an impressive academic resume and a strong connection to his community through extracurricular activities. Most, quite impressively, received national recognition as the 2023 National FFA Organization Extemporaneous Public Speaking Winner. He was also the recipient of the KCFF 2023 Cliff and Ruth Hermance Scholarship. In addition, Most's roots reach deeply into Keith County, as a fifth generation Keith Countian.

In 2023, NCF hometown interns represented fifteen Nebraska communities. Many interns reported positive experiences. A compelling desire to follow the success of the projects and continue with the program explains why some choose to return after one year. KCFF's past interns include Rachel Orth and Miah Hoppens. Orth has continued to work with NCF since her year as a KCFF intern and has even helped with the intern program.

KCFF is excited that Ogallala will be the host city for the first NCF HTI peer learning sessions planned this summer in May. When Hoppens was an intern, she had hoped to invite her fellow interns to Keith County, believing that they would fall in love with what she loved, Keith County. Hosting the peer sessions will now provide the opportunity for the interns to see first-hand what Miah recognized, the beauty of the geography and more importantly the beauty of the people.

KCFF Offers Childcare Provider Incentive Program

Propelling childcare providers from the status of great program administration. SUTQ also lists providers and to even better is the goal of the Keith County Foundation Fund and its cash incentive program that was initiated in January.

Licensed childcare providers in Keith County have the opportunity to participate in the Step Up To Quality (SUTQ) program and earn cash incentives for achieving specific matters here." levels. Providers who complete Step 4 will earn \$5,000; and those who attain Step 5, will be awarded \$10,000, for a total of \$15,000.

"We want to show our providers that we appreciate their efforts in always striving to be their best," said Angie Kolste, KCFF chair.

In 2019, KCFF determined early childhood education to be a priority. Early childhood education and the care of children is far reaching and affects children and families, the work force, and a community's overall wellbeing, Kolste said.

SUTQ, a program of the Nebraska Department of Education, offers childcare providers a pathway, for the betterment of their children's and families' futures, to grow their programs beyond basic childcare. The five-step program is self-paced and includes educational, coaching and resource components, all of which focus on a path to take quality care to the next level. Those qualifying for the local incentive program through KCFF will have three years to complete the program.

Laura Kemp, Keith County Communities for Kids (C4K) coordinator, said childcare programs have changed during the last 20 years and parents want to ensure that there is a focus on early childhood development in their childcare programs.

"SUTQ is a great program to help with that," Kemp said. "The resources that are available for providers are huge, especially because it is harder to get these in the more rural settings. This is a chance for all childcare providers and families to have the opportunity for continued growth and education."

Communities for Kids, a state-wide initiative created in response to community requests for assistance with shortages of high-quality early care and education programs, endorses the SUTQ program.

The SUTQ program encourages participation from licensed family childcare homes and childcare centers, Head Start and Early Head Start programs, public school-operated early childhood programs and licensed preschools. In addition, the program also offers parents a guideline as to what to look for in regard to quality, and addresses the topics of curriculum, learning environments, teacher-child interactions, child outcomes, professional development and training, family engagement and partnerships and

"Newcomers or potential workforce recruits to our community are including quality childcare in their priority lists before accepting a job offer," Kolste said. "SUTQ ratings help newcomers know and understand that quality

High Plains Early Learning Connection coordinator Cheryl Roche said the importance of children having access to quality early learning education and childcare is crucial.

"Ninety percent of children's brains are developed before age 5." Roche said. "Those who provide care to our youngest citizens make a tremendous impact not only on the children but also on families, so it is important that they know and understand how to support early development and learning. Participating in SUTQ gives them the tools to be successful."

According to the Buffett Early Childhood Institute, parents are children's first teachers, but most young children are not with their parents for many hours of the day. In Nebraska, more than 72 percent of children under age 6 live in homes where all adults work. Who is caring for children and how they are doing it matters greatly. The safety, relationships, and interactions between young children and their parents, caregivers, and teachers are the most important elements of a high-quality experience, according to the BECI.

Kemp said it is important parents have choices regarding childcare as providers help to build their children's foundation as learning begins at birth. The KCFF's incentive program can help providers bolster their income while upping the quality of care they provide.

"This program with KCFF is a great partnership not only for C4K but the families and childcare providers of Keith County," Kemp said.

Kemp encourages childcare providers in Keith County who are licensed and in good standing with the Nebraska Department of Health and Human Services to apply for the inventive program.
